Century Fund and Spring Grants Awarded

Roads to Recovery is the recipient of the 2024 \$100,000 Century Fund grant. Now in its fifth year, the Century Fund is awarded once per year through a competitive application process to a local nonprofit organization carrying out a project that is transformational for our community. Roads to Recovery assists people in finding and sustaining recovery from substance use disorders. The Century Fund grant will help with the purchase of furnishings and equipment for a new detox program in Lynchburg, which will deliver withdrawal management and recovery services.

In addition, the GLCF awarded over \$519,000 to local nonprofits this spring through the competitive application process and from donor advised funds. Examples of some of this year's funded projects include: providing healthy meals to homebound individuals, educational summer programming for kids in Campbell County, purchasing tools and equipment to assist in maintaining the Appalachian Trail in Bedford County, supporting elderly patients in hospice care, and the preservation of the historic Dr. Robert Walter "Whirlwind" Johnson home in Lynchburg.
